WHEREAS, BAC Resolution No. BSVP 2023-014-01 for the project **Purchase of Damaged Starter of Water Tank Truck at Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **Ten Thousand Pesos (P 10, 000.00)** hereby form the integral part of this resolution. WHEREAS, (3) Request for Quotations (RFQ) were distributed to different suppliers;

WHEREAS, Acknowledgement Receipts are herewith attached as proof that copies of Request for Quotation (RFQ) were distributed;

WHEREAS, one (1) interested supplier submitted their sealed quotations;

WHEREAS, during the Bid Opening last May 24, 2023, **ILOILO FABRICATION SPECIALISTS INC.** was declared Single Calculated Bid with the Bid amount of **Nine Thousand Nine Hundred Fifty Pesos (P 9, 950.00)**;

WHEREAS, the price quotation of the bidder was found to be substantially compliant:
