RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL FOR REPAIR AND MAINTENANCE OF ISUZU DMAX AT ILOILO INTERNATIONAL AIRPORT

WHEREAS, BAC Resolution No. BSVP 2023-017-01 for the project **Repair and Maintenance of Isuzu DMax at Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **Fifty Two Thousand Five Hundred Pesos (₱ 52, 500.00)** hereby form the integral part of this resolution. WHEREAS, (3) Request for Quotations (RFQ) were distributed to different suppliers;

WHEREAS, during the Bid Opening last May 30, 2023, **CASTLE ROO CAR SERVICES** was declared Single Calculated Bid with the Bid amount of **Forty Nine Thousand Pesos (₱ 49, 000.00)**;
