**RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION AND
RECOMMENDING APPROVAL FOR PURCHASE OF ADDITIONAL DESKTOP
COMPUTER FOR COA USE AT ILOILO INTERNATIONAL AIRPORT**

WHEREAS, BAC Resolution No. BSVP 2023-018-01 for the project **Purchase of Additional Desktop Computer and Printer for COA Use at Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **Fifty Eight Thousand Eight Hundred Eighty Pesos (₱ 58, 880.00)** hereby form the integral part of this resolution. A copy is herewith attached as Annex A;

WHEREAS, (3) Request for Quotations (RFQ) were distributed to different suppliers;

WHEREAS, Acknowledgement Receipts are herewith attached as proof that copies of Request for Quotation (RFQ) were distributed;

WHEREAS, two (2) interested supplier submitted their sealed quotations;

WHEREAS, during the Bid Opening last June 9, 2023, **CYBER LINK COMPU SALES** was declared Single Calculated Bid with the Bid amount of **Fifty Eight Thousand Five Pesos (₱ 58, 005.00)**;

WHEREAS, bid submitted by **COMPUTRON BUSINESS CENTER**, has been disqualified during the bid opening due to non-submission of Eligibility Requirements:

1. *Annual Income Tax Return/Business Tax* and
2. *Tax Clearance submitted was expired last January 12, 2023.*

WHEREAS, the price quotation of the bidder was found to be substantially compliant:

WHEREAS, during the Post Qualification of Documents last June 22, 2023, Bids and Award Committee (BAC) verified the documents and **CYBER LINK COMPU SALES** complied with the requirements as stated in the Notice for Post Qualification Evaluation;

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the Bidder, **CYBER LINK COMPU SALES** was found to be the Single Calculated Responsive Quotation;
