RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL FOR SUPPLY AND DELIVERY OF FLIGHT STRIPS USE FOR ATC CLEARANCES AND ARRIVAL/LET DOWN INFORMATION FOR FY 2023 AT ILOILO INTERNATIONAL AIRPORT

WHEREAS, BAC Resolution No. BSVP 2023-021-01 for the project **Supply and Delivery of Flight Strips Use for ATC Clearances and Arrival/Let Down Information for FY 2023 at Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **Thirty Thousand Pesos (₱ 30, 000.00)** hereby form the integral part of this resolution. WHEREAS, (3) Request for Quotations (RFQ) were distributed to different suppliers;

WHEREAS, Acknowledgement Receipts are herewith attached as proof that copies of Request for Quotation (RFQ) were distributed;

WHEREAS, one (1) interested supplier submitted their sealed quotations;

WHEREAS, during the Bid Opening last June 27, 2023, **MAKINAUGALINGON PRINTER & BOOKBINDER** was declared Single Calculated Bid with the Bid amount of **Eighteen Thousand Nine Hundred Pesos (₱18, 900.00)**;

WHEREAS, the price quotation of the bidder was found to be substantially compliant:
