**RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION  
AND RECOMMENDING APPROVAL FOR PURCHASE OF PRINTERS FOR FY 2023  
AT ILOILO INTERNATIONAL AIRPORT**

**WHEREAS**, BAC Resolution No. BSVP 2023-025-01 for the project **Purchase of Printers for FY 2023 at Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **Thirty Thousand Seven Hundred Eighty Pesos (₱ 30, 780.00)** hereby form the integral part of this resolution. A copy is herewith attached as Annex A;

**WHEREAS**, (3) Request for Quotations (RFQ) were distributed to different suppliers;

**WHEREAS**, Acknowledgement Receipts are herewith attached as proof that copies of Request for Quotation (RFQ) were distributed;

**WHEREAS**, one (1) interested supplier submitted their sealed quotations;

**WHEREAS**, during the Bid Opening last July 24, 2023, **CYBER LINK COMPU SALES** was declared Single Calculated Bid with the Bid amount of **Thirty Thousand Six Hundred Pesos (₱ 30, 600.00)**;

**WHEREAS**, the price quotation of the bidder was found to be substantially compliant:

**WHEREAS**, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the Bidder, **CYBER LINK COMPU SALES** was found to be the Single Calculated Responsive Quotation;


**NOW THEREFORE**, We, the Members of the Bids and Awards Committee hereby **RESOLVE** as it is hereby **RESOLVED**:

- b) To recommend for approval by the Head of the Procuring Entity of the Civil Aviation Authority of the Philippines the foregoing findings.




