RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL FOR PURCHASE OF MATERIALS FOR 13 UNITS LED FLOODLIGHTS FOR HIGH MAST NO. 1 TO 6 OF ILOILO INTERNATIONAL AIRPORT

WHEREAS, BAC Resolution No. BSVP 2023-030-01 for the project **Purchase of Materials for 13 Units LED Floodlights for High Mast No. 1 to 6 of Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **Seven Thousand Eight Hundred Thirty Seven Pesos & 88/100 (P7,837.88)** hereby form the integral part of this resolution. A copy is herewith attached as Annex A;

WHEREAS, (3) Request for Quotations (RFQ) were distributed to different suppliers;

WHEREAS, Acknowledgement Receipts are herewith attached as proof that copies of Request for Quotation (RFQ) were distributed;

WHEREAS, one (1) interested supplier submitted their sealed quotations;

WHEREAS, during the Bid Opening last August 14, 2023, **EAJ CONSTRUCTION AND SUPPLY** was declared Single Calculated Bid with the Bid amount of **Seven Thousand Eight Hundred Eighteen Pesos (P 7,818.00)**;

WHEREAS, the price quotation of the bidder was found to be substantially compliant:

WHEREAS, the detailed evaluation of quotations conducted resulted in the following:

WHEREAS, **EAJ CONSTRUCTION AND SUPPLY.**, was then sent a Notice for Post Qualification Evaluation and was given five (5) days to comply with the documentary requirements and verification for Post-Qua;

WHEREAS, during the Post Qualification of Documents last August 25, 2023, Bids and Award Committee (BAC) verified the documents and **EAJ CONSTRUCTION AND SUPPLY** complied with the requirements as stated in the Notice for Post Qualification Evaluation;

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the Bidder, **EAJ CONSTRUCTION AND SUPPLY** was found to be the Single Calculated Responsive Quotation;

WHEREAS, in Section 34.4 of the 2016 revised IRR of RA No.9184: *"If the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid passes all the criteria for post-qualification, it shall declare the said bid as the LCRB or HRRB, and recommend to the HoPE the award of contract to the said bidder at its submitted bid price or its calculated bid price, whichever is lower or, in the case of quality-based evaluation procedure, submitted bid price or its negotiated price, whichever is lower."*

NOW THEREFORE, the Members of the Bids and Awards Committee hereby **RESOLVE** as it is hereby **RESOLVED**:


