**WHEREAS**, BAC Resolution No. BSVP 2023-027-01 for the project **Supply and Delivery of Steel Cabinets and High Chairs of Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **Sixty Two Thousand Seven Hundred Twenty Five Pesos (₱ 62,725.00)** hereby form the integral part of this resolution. **WHEREAS**, (3) Request for Quotations (RFQ) were distributed to different suppliers;

**WHEREAS**, during the Bid Opening last August 22, 2023, **NEW ILOILO IZEEM COMMERCIAL SUMMIT INC.** was declared Single Calculated Bid with the Bid amount of **Sixty Thousand Nine Hundred Pesos (₱ 60,900.00)**;
