**RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION
 AND RECOMMENDING APPROVAL FOR SUPPLY AND DELIVERY OF SEMI
 EXPANDABLE SUPPLIES FOR 2023 OF ILOILO INTERNATIONAL AIRPORT**

WHEREAS, BAC Resolution No. BSVP 2023-028-01 for the project **Supply and Delivery of Semi Expandable Supplies for 2023 of Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **One Hundred Sixty Four Thousand Two Hundred Ninety Seven Pesos & 50/100 (₱ 164,297.50)** hereby form the integral part of this resolution. WHEREAS, (3) Request for Quotations (RFQ) were distributed to different suppliers;

WHEREAS, Acknowledgement Receipts are herewith attached as proof that copies of Request for Quotation (RFQ) were distributed;

WHEREAS, one (1) interested supplier submitted their sealed quotations;

WHEREAS, during the Bid Opening last August 22, 2023, **NEW ILOILO IZEEM COMMERCIAL SUMMIT INC.** was declared Single Calculated Bid with the Bid amount of **One Hundred Sixty One Thousand Seven Hundred Pesos (₱ 161,700.00)**;

WHEREAS, the price quotation of the bidder was found to be substantially compliant:
