## BAC Resolution No. BSVP 2023-029-02

## RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL FOR SUPPLY AND DELIVERY OF PHILIPPINE FLAG AND WINDCONE OF ILOILO INTERNATIONAL AIRPORT

WHEREAS, BAC Resolution No. BSVP 2023-029-01 for the project Supply and Delivery of Philippine Flag and Windcone of Iloilo International Airport with Approved Budget for the Contract (ABC) in the amount of Thirty Seven Thousand Four Hundred Ten Pesos (P 37,410.00) hereby form the integral part of this resolution. A copy is herewith attached as Annex A;

WHEREAS, (3) Request for Quotations (RFQ) were distributed to different suppliers;

WHEREAS, Acknowledgement Receipts are herewith attached as proof that copies of Request for Quotation (RFQ) were distributed;

WHEREAS, one (1) interested supplier submitted their sealed quotations;

WHEREAS, during the Bid Opening last August 14, 2023, UNI-ART SUPPLY, INC. was declared Single Calculated Bid with the Bid amount of Thirty Six Thousand Four Hundred Fifty Pesos (\$\mathbf{P}\$ 36, 450.00);

WHEREAS, the price quotation of the bidder was found to be substantially compliant:

WHEREAS, during the Post Qualification of Documents last August 25, 2023, Bids and Award Committee (BAC) verified the documents and UNI-ART SUPPLY, INC. complied with the requirements as stated in the Notice for Post Qualification Evaluation;

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the Bidder, UNI-ART SUPPLY, INC. was found to be the Single Calculated Responsive Quotation;

**NOW THEREFORE**, the Members of the Bids and Awards Committee hereby RESOLVE as it is hereby RESOLVED:

- a) To declare, UNI-ART SUPPLY, INC. as the Supplier with the Single Calculated Responsive Quotation Supply and Delivery of Philippine Flag and Windcone of Iloilo International Airport in the bid amount of Thirty Six Thousand Four Hundred Fifty Pesos (P 36, 450.00);
- b) To recommend for approval by the Head of the Procuring Entity of the Civil Aviation Authority of the Philippines the foregoing findings.
