**RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION
AND RECOMMENDING APPROVAL FOR REPAIR AND MAINTENANCE OF
CLOSE CIRCUIT TELEVISION AT ILOILO INTERNATIONAL AIRPORT**

WHEREAS, BAC Resolution No. BSVP 2022-014-01 for the project **Repair and Maintenance of Close Circuit Television at Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **Eight Hundred Thirty Seven Thousand Nineteen Pesos & 43/100 (₱ 837,019.43)** hereby form the integral part of this resolution.
