INVITATION TO BID FOR

PROVISION OF SECURITY SERVICES REQUIREMENTS FOR CAAP AREA XI UNDER A THREE (3)-YEAR SERVICE AGREEMENT

- 1. The CIVIL AVIATION AUTHORITY OF THE PHILIPPINES (CAAP), through the Corporate Operating Budget (COB) for FY 2022 intends to apply the sum of Seventy Seven Million Two Hundred Fifty Five Thousand Seventy Two Pesos and 40/100 (Php 77,255,072.40) for the First One Year only, being the ABC to payments under the contract for Provision of Security Services Requirements for CAAP AREA XI under a Three (3)-Year Service Agreement. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The **CAAP** now invites bids for the above Procurement Project (see details in the attached Terms of Reference). Delivery of the Goods is required for the **First One Year only**. Bidders should have completed, within **Three (3) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

- Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- 4. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- Prospective Bidders may obtain further information from the CAAP Bids and Awards Committee for Security Services and inspect the Bidding Documents at the address given below during Regular Office Hours from 8:00 A.M. to 5:00 P.M. (Monday to Friday).
- A complete set of Bidding Documents may be acquired by interested Bidders on the 03
 October 2022 until the deadline of submission of bid from the given address and website(s)



below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php 56,000.00 (inclusive of 12% VAT). The Procuring Entity shall allow the bidder to present its proof of payment for the fees by presenting the official receipt in person.

- 7. The CAAP will hold a Pre-Bid Conference¹ on 10 October 2022 @ 10:00 AM at CAAP Conference Room, CAAP Compound, MIA Road Ninoy Aquino Avenue, 1300 Pasay City and/or through video conferencing or webcasting via Google Meet, which shall be open to prospective bidders.
- Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before 24 October 2022 @ 10:00 AM. Late bids shall not be accepted.
- All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
- 10. Bid opening shall be on 24 October 2022 @ 10:00 AM at the given address below and/or via Google Meet. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 11. The CAAP reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
