



INVITATION TO BID

FOR TRUCKING SERVICES FOR TRANSFER OF X-RAY MACHINES FROM CAAP

1. The Civil Aviation Authority of the Philippines (CAAP), through the Corporate Operating Budget (COB) for FY 2022 intends to apply the total sum of **Two Million Three Thousand One Hundred Twenty Pesos (Php 2,003,120.00)**, being the **Approved Budget for the Contract (ABC)** to payments under the contract **Trucking Services for Transfer of X-Ray Machines from CAAP Main Office to Various Airports with BID NO. 22-019-10 (RE-BID)**

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The **CAAP** now invites bids for the above Procurement Project. Delivery of the Goods is required within **ninety (90) calendar days**. Bidders should have completed, within **Three (3) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from **BAC Secretariat of CAAP, MIA Road, Pasay City** and inspect the Bidding Documents at the address given below during **office hours from 8:00 A.M. to 5:00 P.M. (Monday to Friday)**.
5. A complete set of Bidding Documents may be acquired by interested Bidders **on 18 November 2022 until the deadline of submission of bids** from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Php 5,600.00 (inclusive of 12% VAT)**. The



Procuring Entity shall allow the bidder to present its proof of payment for the fees by **presenting the official receipt in person/through email.**

6. The **CAAP** will hold a Pre-Bid Conference¹ on **29 November 2022 @ 10:00 AM** through video conferencing or webcasting *via Google Meet*, which shall be open to prospective bidders, who will coordinate with the BAC Secretariat for the Google Meet link.
7. Bids must be duly received by the BAC Secretariat through **manual submission at the office address indicated below**, on or before **13 December 2022 @ 2:00 PM**. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on **13 December 2022 @ 2:00 PM** at the given address below and/or via **video conferencing Google Meet application**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The **CAAP** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
