**INVITATION TO BID FOR  
SUPPLY AND INSTALLATION OF THREE (3) UNITS 600 KW CHILLER AT  
ILOILO INTERNATIONAL AIRPORT  
(Bid No. 23-010-05)**

1. The Civil Aviation Authority of the Philippines (CAAP), through the CAAP APP CY 2023 intends to apply the sum of **THIRTY-NINE MILLION EIGHTY-FOUR THOUSAND SIX HUNDRED SEVENTY-THREE & 92/100 (PHP 39,084,673.92)** being the ABC to payments under the contract for **SUPPLY AND INSTALLATION OF THREE (3) UNITS 600 KW CHILLER AT ILOILO INTERNATIONAL AIRPORT (Bid No. 23-010-05)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Civil Aviation Authority of the Philippines now invites bids for the above Procurement Project. Delivery of the Goods is required by **Two Hundred Ten (210) calendar days**. Bidders should have completed, within seven (7) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.  
Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184.
4. Prospective Bidders may obtain further information from Civil Aviation Authority of the Philippines and inspect the Bidding Documents at the address given below during working days at 8:00AM to 5:00PM.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **03 May 2023 until deadline of submission of bid** from the given address and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Php 28,000.00 (inclusive of 12% VAT)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees by presenting the official receipt in person.
6. The Civil Aviation Authority of the Philippines will hold a Pre-Bid Conference<sup>1</sup> on **11 May 2023 @ 10:00 AM** through video conferencing/webcasting via Jitsi/Zoom/Google Meet, which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat through manual submission at CAAP-BAC Office, CAAP Compound, MIA Road corner Ninoy Aquino Avenue, 1300 Pasay City, Metro Manila on or before **25 May 2023 @ 10:00 AM**. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on **25 May 2023 @ 10:00 AM** at the given address below and/or via Jitsi/Zoom/Google Meet. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The Civil Aviation Authority of the Philippines reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
