**RESOLUTION RECOMMENDING FOR THE SUSPENSION OF THE  
PROCUREMENT PROCESS OF PROJECT SUPPLY AND DELIVERY OF FIRE  
FIGHTING SUPPLIES & MATERIALS OF MORITA AND OSHKOSH  
FIRETRUCKS OF ILOILO INTERNATIONAL AIRPORT DUE TO PENDING  
DESIGNATION OF A NEW HEAD OF PROCURING ENTITY (HoPE) OR  
OFFICER IN-CHARGE AT ILOILO INTERNATIONAL AIRPORT**

**WHEREAS**, due to the demise of the Head of Procuring Entity (HoPE) Mr. Efren N. Nagrama last July 2, 2022 projects of Iloilo International Airport under his signatories shall be temporarily suspended;

**WHEREAS**, the procurement process for the project **Supply and Delivery of Fire Fighting Supplies & Materials of Morita and Oshkosh Firetrucks of Iloilo International Airport** with the ABC of **Four Million Nine Hundred Fifteen Thousand Seven Hundred Forty Seven Pesos & 29/100 (₱4,915,747.29)** shall be temporarily suspended;

**WHEREAS**, the status of project is for signature of the HoPE of the Notice to Proceed;

**WHEREAS**, the resumption of the Procurement process shall be resumed once an Officer In-charge or replacement shall be designated for and in his behalf;

**WHEREAS**, bidder of the said project shall be informed thru writing about this development;

**WHEREAS**, the Bids and Awards Committee (BAC) Iloilo Airport hereby recommends for the suspension of the procurement process until further notice;

**NOW THEREFORE**, for and in any consideration of the above premises, the CAAP-BAC Iloilo International Airport **RESOLVES**, as it is hereby **RESOLVED**, the procurement process is hereby suspended until further notice;

**IN WITNESS THEREOF**, the CAAP-BAC Iloilo Airport signed **Resolution No. 2022-007-03** this **4<sup>th</sup> day of July 2022** at the Civil Aviation Authority of the Philippines, Iloilo Airport, Cabatuan, Iloilo.




