RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID AND RECOMMENDING APPROVAL FOR THE REPAIR AND MAINTENANCE OF 3 UNITS PASSENGER BOARDING BRIDGES AT ILOILO INTERNATIONAL AIRPORT

WHEREAS, The Civil Aviation Authority of the Philippines advertised the Invitation to Apply for Eligibility and to Bid for **REPAIR AND MAINTENANCE OF 3 UNITS PASSENGER BOARDING BRIDGES AT ILOILO INTERNATIONAL AIRPORT** in the PhilGEPS and in conspicuous place at the premises of the Civil Aviation Authority of the Philippines with the ABC of **ONE MILLION THREE HUNDRED FORTY TWO THOUSAND FORTY PESOS & 23/100 (₱ 1,342,040.23)**;

WHEREAS, in response to the said advertisement, one (1) interested bidders submitted their letter of intent and bought the bidding documents;

WHEREAS, on the day of the Preliminary Examination of Bids, only One (1) bidder submitted their sealed bid proposal;

WHEREAS, during the Bid Opening last July 14, 2022, **ALJON INTERNATIONAL CORPORATION** was declared Single Calculated Bid with the Bid Amount of **ONE MILLION THREE HUNDRED FOURTEEN THOUSAND SEVEN HUNDRED SEVENTY SIX PESOS PESOS & 09/100 ONLY (₱1,314,776.09)**. **ALJON INTERNATIONAL CORPORATION** was then sent a Notice for Post Qualification Evaluation and was given five (5) days to comply with the documentary requirements and verification for Post-Qua;

WHEREAS, for the price quotations Bidder have substantially complied:


