RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID AND RECOMMENDING APPROVAL FOR THE REPAINTING WORKS FOR RUNWAY DAY MARKERS AND MARKINGS AT ILOILO INTERNATIONAL AIRPORT

WHEREAS, The Civil Aviation Authority of the Philippines advertised the Invitation to Apply for Eligibility and to Bid for **REPAINTING WORKS FOR RUNWAY DAY MARKERS AND MARKINGS AT ILOILO INTERNATIONAL AIRPORT** in the PhilGEPS and in conspicuous place at the premises of the Civil Aviation Authority of the Philippines with the ABC of **ONE MILLION NINE HUNDRED ONE THOUSAND SEVEN HUNDRED THIRTY PESOS ONLY (₱ 1,901,730.00)**;

WHEREAS, in response to the said advertisement, three (3) interested bidders submitted their letter of intent and bought the bidding documents;

WHEREAS, on the day of the Preliminary Examination of Bids, only One (1) bidder submitted their sealed bid proposal;

WHEREAS, during the Bid Opening last June 20, 2022, **ULTIMATE B CONSTRUCTION AND SUPPLIES, INC.** was declared Single Calculated Bid with the Bid Amount of **ONE MILLION EIGHT HUNDRED EIGHTY ONE THOUSAND EIGHT HUNDRED ELEVEN PESOS & 20/100 ONLY (₱1,881,811.20)**. **ULTIMATE B CONSTRUCTION AND SUPPLIES, INC.** was then sent a Notice for Post Qualification Evaluation and was given five (5) days to comply with the documentary requirements and verification for Post-Qua;

WHEREAS, for the price quotations Bidder have substantially complied:

WHEREAS, during the Post Qualification of Documents last June 29, 2022, Technical Working Group (TWG) and Bids and Awards Committee (BAC) verified the documents and **ULTIMATE B CONSTRUCTION AND SUPPLIES, INC.** complied with the requirements as stated in the Notice for Post Qualification Evaluation;

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the Bidder **ULTIMATE B**



CONSTRUCTION AND SUPPLIES, INC. was declared as Single Calculated Responsive Bid;

WHEREAS, BAC Resolution No. 2022-010-03 dated July 4, 2022 "**RESOLUTION RECOMMENDING FOR THE SUSPENSION OF THE PROCUREMENT PROCESS OF PROJECT REPAINTING WORKS FOR RUNWAY DAY MARKERS AND MARKINGS AT ILOILO INTERNATIONAL AIRPORT DUE TO PENDING DESIGNATION OF A NEW HEAD OF PROCURING ENTITY (HoPE) OR OFFICER IN-CHARGE AT ILOILO INTERNATIONAL AIRPORT**" was issued due to the demise of the Head of Procuring Entity (HoPE), Mr. Efren N. Nagrama last July 2, 2022. **ULTIMATE B CONSTRUCTION AND SUPPLIES, INC.** was informed thru writing about the development of the project;

WHEREAS, BAC Resolution No. 2022-010-04 dated August 8, 2022 "**RESOLUTION RECOMMENDING RESUMPTION OF THE PROCUREMENT PROCESS FOR THE REPAINTING WORKS FOR RUNWAY DAY MARKERS AND MARKINGS AT ILOILO INTERNATIONAL AIRPORT DUE TO DESIGNATION OF THE NEW HEAD OF PROCURING ENTITY (HoPE) OR OFFICER IN-CHARGE AT ILOILO INTERNATIONAL AIRPORT**" was issued due to the Designation of Engr. Eusebio Monserate Jr. as Acting Area Manager, Area Center VI as per Authority Order No. 160-2022, dated August 5, 2022;

NOW THEREFORE, We, the Members of the Bids and Awards Committee hereby **RESOLVE** as it is hereby **RESOLVED**:

- a) To declare **ULTIMATE B CONSTRUCTION AND SUPPLIES, INC.** as the Supplier with the Single Calculated Responsive Bid for the **REPAINTING WORKS FOR RUNWAY DAY MARKERS AND MARKINGS AT ILOILO INTERNATIONAL AIRPORT** in the bid amount of **ONE MILLION EIGHT HUNDRED EIGHTY ONE THOUSAND EIGHT HUNDRED ELEVEN PESOS & 20/100 ONLY (₱1,881,811.20)**;
- b) To recommend for approval by the Head of the Procuring Entity of the Civil Aviation Authority of the Philippines the foregoing findings.

Resolved this 10th day of August 2022 at the Civil Aviation Authority of the Philippines, Iloilo Airport, Cabatuan, Iloilo.








