RESOLUTION DECLARING LOWEST CALCULATED RESPONSIVE BID AND RECOMMENDING APPROVAL FOR SUPPLY & DELIVERY OF VARIOUS JANITORIAL SUPPLIES FOR THE MONTH OF MAY TO JUNE 2023 OF ILOILO INTERNATIONAL AIRPORT

WHEREAS, The Civil Aviation Authority of the Philippines advertised the Invitation to Apply for Eligibility and to Bid for Supply & Delivery of Various Janitorial Supplies for the month of May to June 2023 of Iloilo International Airport in the Philippines and in conspicuous place at the premises of the Civil Aviation Authority of the Philippines with the ABC of One Million One Hundred Forty Three Thousand Twelve Pesos & 55/100 (P 1,143,012.55);
