**RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID AND
 RECOMMENDING APPROVAL FOR THE SUPPLY, DELIVERY AND
 INSTALLATION OF SOLAR LIGHTS AT AIRSIDE PERIMETER FENCE AT
 ILOILO INTERNATIONAL AIRPORT**

WHEREAS, The Civil Aviation Authority of the Philippines advertised the Invitation to Apply for Eligibility and to Bid for the **Supply, Delivery and Installation of Solar Lights at Airside Perimeter Fence at Iloilo International Airport** in the PhilGEPS and in conspicuous place at the premises of the Civil Aviation Authority of the Philippines with the ABC of **Three Million Five Hundred Forty Nine Thousand Forty Six Pesos & 52/100 (P 3,549,046.52)**;

WHEREAS, in response to the said advertisement, four (4) interested bidder submitted their letter of intent and bought the bidding documents;

WHEREAS, on the day of the Preliminary Examination of Bids, four (4) bidder submitted their sealed bid proposals;

WHEREAS, during the Bid Opening last July 13, 2023, **TOPMOST DEVELOPMENT & MARKETING CORPORATION** was declared Lowest Calculated Bid with the Bid amount **Three Million One Hundred Eighty Five Thousand Eight Hundred Thirty Four Pesos & 12/100 (P 3,185,834.12)**;

WHEREAS, bid submitted by **PAG-UN BUILDERS & SUPPLY** has been disqualified during the bid opening due to non-compliance of requirements, as indicated in the **Section 32.2.1**. *“a) Completeness of the bid. Unless the Instructions to Bidders specifically allow partial bids, bids not addressing or providing all of the required items in the Bidding Documents including, where applicable, bill of quantities, shall be considered non-responsive and, thus, automatically disqualified. In this regard, where a required item is provided, but no price is indicated, the same shall be considered as non-responsive, but specifying a zero (0) or a dash (-) for the said item would mean that it is being offered for free to the Government, except those required by law or regulations to be provided for”*. Based on 2016 revised IRR of RA No.9184; and **THREE N’ ONE ENTERPRISES** has been disqualified during the bid opening due to non-compliance of requirements, as indicated in the **Section 25**. Submission and Receipt of Bids of the 2016 revised IRR of RA No.9184:
“Bidders shall submit their bids through their duly authorized representative using the form specified in the bidding documents in two (2) separate sealed bid envelopes under Sections 25.1.

WHEREAS, the price quotations of the bidder was found to be substantially complying:

WHEREAS, upon submission and conduct of the Post Qualification Evaluation for the **TOPMOST DEVELOPMENT & MARKETING CORPORATION** last July 25, 2023, the Lowest Calculated Bidder was post-disqualified as per **TWG POST EVALUATION AND RECOMMENDATION FOR SUPPLY, DELIVERY AND INSTALLATION OF SOLAR LIGHTS AT AIRSIDE PERIMETER FENCE AT ILOILO INTERNATIONAL AIRPORT** dated July 26, 2023 and Notice of Post – Disqualification was sent last July 31, 2023 (see attached TWG Post Evaluation and Recommendation);

WHEREAS, **BAC RESOLUTION NO. 2023-005-03** dated **August 8, 2023** was issued recommending for the Post – Qualification Evaluation for the Second Lowest Calculated Bidder, **ILOILO PARAMOUNT INDUSTRIAL AND ELECTRICAL CO. INC.;**

WHEREAS, during the Post Qualification of Documents last August 11, 2023, the TWG and BAC verified its documents and **ILOILO PARAMOUNT INDUSTRIAL AND ELECTRICAL CO. INC.** complied with the requirements as stated in the TWG Post Evaluation and Recommendation (see attached TWG Post Evaluation and Recommendation); Notice of Result of Post – Qua Evaluation was received by **ILOILO PARAMOUNT INDUSTRIAL AND ELECTRICAL CO. INC.** last **August 22, 2023;**

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the bidder and the post – disqualification of **TOPMOST DEVELOPMENT & MARKETING CORPORATION, ILOILO PARAMOUNT INDUSTRIAL AND ELECTRICAL CO. INC.,** was declared as Single Calculated Responsive Bid;

WHEREAS, in **Section 34.4** of the 2016 revised IRR of RA No.9184: *“If the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid passes all the criteria for post-qualification, it shall declare the said bid as the LCRB or HRRB, and recommend to the HoPE the award of contract to the said bidder at its submitted bid price or its calculated bid price, whichever is lower or, in the case of quality-based evaluation procedure, submitted bid price or its negotiated price, whichever is lower.”*


