**RESOLUTION DECLARING LOWEST CALCULATED RESPONSIVE BID AND

AND IT SUPPLIES FOR THE MONTHS OF MAY TO DECEMBER 2023 OF ILOILO
INTERNATIONAL AIRPORT**

WHEREAS, The Civil Aviation Authority of the Philippines advertised the Invitation to Apply for Eligibility and to Bid for Supply & Delivery of Various Office and IT Supplies for the months of May to December 2023 of Iloilo International Airport in the PhilGEPS and in conspicuous place at the premises of the Civil Aviation Authority of the Philippines with the ABC of Seven Hundred Thirty Five Thousand Nine Hundred Sixteen Pesos & 40/100 (₱ 735,916.40);

WHEREAS, in response to the said advertisement, four (4) interested bidder submitted their letter of intent and bought the bidding documents;

WHEREAS, on the day of the Preliminary Examination of Bids, four (4) bidder submitted their sealed bid proposals;
