**BAC RESOLUTION DECLARING THE CANCELLATION AND TERMINATION OF
THE PROCUREMENT PROCESS**

WHEREAS, the Civil Aviation Authority of the Philippines Area X Laguindingan Airport, through the Bids and Awards Committee, advertised the Invitation to Bid at the CAAP website, PhilGEPS and CAAP Laguindingan Bulletin Board the procurement of the project described hereunder, with its corresponding Approved Budget for the Contract (ABC).

WHEREAS, the end-user justified that upon careful review and assessment of the submitted Scope of Works, it was found that the incorporation of civil works for the project was inadvertently omitted; hence, should the procurement process thereof be continued, the same shall eventually become futile and impractical on the part of the government, not to mention the wastage of public fund.

WHEREAS, the procurement of Apron lighting necessitates the mobilization and/or demobilization so as to complete the construction of the enclosed wooden box for the damaged 1000Watts HID Lamps, including the provision of equipment for the said repair/replacement.

WHEREAS, the use of equipment to repair/replace the damaged stainless steel wire rope is needed since it requires the dismantling and assembling of structures to repair the said wire rope.

WHEREAS, considering that the insulation around the wires and/or other conductors is already worn, frayed, and damaged, there is a need, therefore, for its repair, otherwise, the installation and replacement thereof will become useless since damaged insulation could cause short-circuit, leading to arcing or fire.
