This refers to the Competitive Bidding for the contract "COMPREHENSIVE PEST CONTROL FOR ALL BUILDINGS OF DIA COMPLEX (PTB, CARGO, ATC/ADMIN BUILDING, CENTRAL PLANT BLDG, MOTORPOOL AND MAINTENANCE BLDG AND ARFF BLDG) AT DIAA" conducted by the Civil Aviation Authority of the Philippines - Area XI, the Procuring Entity.

- Surety bond callable upon demand issued by a surety or insurance company duly certified
  by the Insurance Commission as authorized to issue such security Thirty Percent
  (30%) of the Total Contract Price

The performance security shall be posted in favor of the Procuring Entity and shall contain the conditions prescribed by R.A. 9184 and its implementing rules and regulations, as amended. Failure to enter into the said contract or provide the required Performance Security shall disqualify the bid of MAPECON PHILIPPINES, INC. and render this notice canceled.
