### Contract Agreement

THIS AGREEMENT, made on FEB 0 3 2023 between CIVIL AVIATION AUTHORITY OF THE PHILIPPINES - AREA XI of Davao City, Philippines (hereinafter called "the Entity") and RSLORENZO CONSTRUCTION of Davao City, Philippines (hereinafter called "the Contractor").

WHEREAS, the Entity is desirous that the Contractor execute "Construction of Guard Post (Various Elevation) (12 units - Guard Post & 5 units - Elevated Guard Post) at General Santos City International Airport" with the Purchase Request No. 2022-10-261 (hereinafter called "the Works" and the entity has accepted the Bid for TWO MILLION SIX HUNDRED FIFTY-FIVE THOUSAND NINETEEN PESOS AND SIXTY-NINE CENTAVOS (₱ PHP 2,655,019.69) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:
  - A. Philippine Bidding Documents (PBDs);
    - Drawings/Plans;
    - ii. Specifications;
    - iii. Bill of Quantities;
    - iv. General and Special Conditions of Contract;
    - v. Supplemental or Bid Bulletins, if any;
    - vi. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
  - B. Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - C. Performance Security;
  - Notice of Award of Contract and the Bidder's conforme thereto; and
  - E. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are

subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

- 3. In consideration for the sum of TWO MILLION SIX HUNDRED FIFTY-FIVE THOUSAND NINETEEN PESOS AND SIXTY-NINE CENTAVOS (\*P PHP 2,655,019.69), RSLORENZO CONSTRUCTION agrees to implement and finish the Construction of Guard Post (Various Elevation) (12 units - Guard Post & 5 units - Elevated Guard Post) at General Santos City International Airport in accordance with his/her/its Bid.
- 4. The CIVIL AVIATION AUTHORITY OF THE PHILIPPINES AREA XI agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
