The **CIVIL AVIATION AUTHORITY OF THE PHILIPPINES**, through its Area XI Bids and Awards Committee intends to invite bids for the following project(s):

The Civil Aviation Authority of the Philippines (CAAP) - Area XI, through the DOTr-downloaded project GAA CY 2017 intends to apply the sum of TWO MILLION EIGHT HUNDRED FIFTY-ONE THOUSAND THIRTY-EIGHT PESOS AND NINETY-SIX CENTAVOS 96/100 ONLY (PhP 2,851,038.96) being the Approved Budget for the Contract (ABC) to payments under the contract for the "COTABATO AIRPORT DEVELOPMENT PROJECT (IMPROVEMENT OF LANDSIDE AREA AND AIRSIDE AREA)". Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Civil Aviation Authority of the Philippines (CAAP) - Area XI now invites bids for "COTABATO AIRPORT DEVELOPMENT PROJECT (IMPROVEMENT OF LANDSIDE AREA AND AIRSIDE AREA)" at Cotabato Airport, Brgy. Awang Datu Odin Sinsuat, Maguindanao. Completion of the Works is required within 60 calendar days (inclusive of 13 rainy/unworkable days). Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act." Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from Bids and Awards Committee (BAC) Secretariat, CAAP Area XI and inspect the Bidding Documents at the address given below during business days and hours.

A complete set of Bidding Documents may be acquired by interested bidders on August 17, 2023 12:00 AM until the deadline of submission of bids on September 4, 2023 at 5:00 PM from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of PhP 5,000.00 (EXCLUSIVE OF VAT).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

The CIVIL AVIATION AUTHORITY OF THE PHILIPPINES will hold a Pre-Bid Conference on August 24, 2023 at 2:00 PM via online video conference. Link for the online pre-bidding conference shall be sent to the interested bidder's individual email thus, bidders shall signify their intent to attend the pre-bidding by via email at baccaapareaxi@gmail.com.

All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18. Bidders shall attach their Site Inspection Certificate upon submission.
