Enforcement and Legal Service

(ELS)

REPUBLIC ACT NO. 9497 Civil Aviation Authority Act of 2008

SECTION 36. The Office of Enforcement and Legal Service.

To effectively implement the civil aviation regulatory, supervisory and administrative mandates of the Director General under this Act, a permanent office within the Authority to be known as the Enforcement and Legal Service, to be composed of in-house counsels of the Authority and its necessary support staff shall be established by the Board.

This office shall provide adequate legal assistance and support to the Director General and to the Authority, as a whole, in the exercise of quasi-legislative and quasi-judicial power as provided for under this Act.

The exercise of the function by the Director General to issue *subpoena ad testificandum*, *subpoena duces tecum* and the imposition of any administrative sanction shall be within the exclusive determination and recommendation of the Enforcement and Legal Service.

MANDATES

The Enforcement and Legal Service (ELS) shall provide adequate legal assistance and support to the Director General and to the Authority, as a whole, and the exercise of quasi-legislative and quasi-judicial power as provided for under this Act.

The exercise of the function by the Director General to issue subpoena ad testificandum, subpoena duces tecum and the imposition of any administrative sanction shall be within the exclusive determination and recommendation of Enforcement and Legal Service.

MISSION

To provide efficient Legal Service:

- in the effective implementation and enforcement of the regulatory, supervisory and administrative mandates of the director General.
- in CAAP's exercise of its quasi-legislative and quasi-judicial power.
- in the determination, recommendation of the issuance of subpoena ad testificandum, subpoena duces tecum and imposition of any administrative sanction.
- in support of CAAP to increase the level of safety, greater capacity in aviation operation towards global competitiveness and in compliance with the Standard and Recommended Practices (SARPs) of International Civil Aviation Organization (ICAO).
