RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID AND RECOMMENDING APPROVAL HOTEL ACCOMMODATION FOR AUDITORS OF CERTIFICATION SERVICES FOR ISO 14001: 2015 ENVIRONMENTAL MANAGEMENT SYSTEM CERTIFICATION AT ILOILO INTERNATIONAL AIRPORT

WHEREAS, BAC Resolution No. RFP BSVP 2022-002-02 for the project HOTEL ACCOMMODATION FOR AUDITORS OF CERTIFICATION SERVICES FOR ISO 14001: 2015 ENVIRONMENTAL MANAGEMENT SYSTEM CERTIFICATION AT ILOILO INTERNATIONAL AIRPORT with Approved Budget for the Contract (ABC) in the amount of THIRTY-SEVEN THOUSAND FIVE HUNDRED PESOS ONLY (P 37,500.00) hereby form the integral part of this resolution. WHEREAS, one (1) interested supplier submitted their sealed quotations;

WHEREAS, during the Bid Opening December 23, 2022, GRAND XING IMPERIAL HOTEL was declared Single Calculated Bid with the Bid Amount of SIXTEEN THOUSAND EIGHT HUNDRED PESOS ONLY (P16,800.00). GRAND XING IMPERIAL HOTEL was then sent a Notice for Post Qualification Evaluation and was given five (5) days to comply with the documentary requirements and verification for Post-Qua;

NOW THEREFORE, We, the Members of the Bids and Awards Committee hereby RESOLVE as it is hereby RESOLVED:

- a) To declare, GRAND XING IMPERIAL HOTEL as the Supplier with the Single Calculated Responsive Bid CERTIFICATION HOTEL ACCOMMODATION FOR AUDITORS OF CERTIFICATION SERVICES FOR ISO 14001: 2015 ENVIRONMENTAL MANAGEMENT SYSTEM CERTIFICATION AT ILOILO INTERNATIONAL AIRPORT in the bid amount SIXTEEN THOUSAND EIGHT HUNDRED PESOS ONLY (P16,800.00);
