This refers to the Competitive Bidding for the contract "INSTALLATION OF ONE (1) UNIT DEEP WELL WATER SYSTEM AT DIAA" conducted by the Civil Aviation Authority of the Philippines - Area XI, the Procuring Entity.

- a. Cash or cashier's/manager's check issued by a Universal or Commercial Bank - **Ten Percent (10%) of the Total Contract Price**
- b. Bank draft/guarantee or irrevocable letter of credit issued by a Universal or Commercial Bank - **Ten percent (10%) of the Total Price**
- c. Surety bond callable upon demand issued by a surety or insurance company duly certified by the Insurance Commission as authorized to issue such security - **Thirty Percent (30%) of the Total Contract Price**

The performance security shall be posted in favor of the Procuring Entity and shall contain the conditions prescribed by R.A. 9184 and its implementing rules and regulations, as amended. Failure to enter into the said contract or provide the required Performance Security shall disqualify the bid of SUREWELL DRILLING CORPORATION and render this notice canceled.

In addition to above-mentioned requirement, SUREWELL DRILLING CORPORATION shall also submit the **Occupational Safety and Health Program approved by Region XI DOLE and Approved Permit to Drill Issued by the National Water Resource Board upon contract signing**, and the following **before the start of the work period**:

1. Construction schedule and S-curve;
2. Construction methods; and
3. Equipment utilization schedule.
