INVITATION TO BID FOR

SUPPLY & DELIVERY OF DISASTER RESPONSE AND AIRPORT RESCUE EQUIPMENT AT CAAP AREA V (BIA, NAGA & MASBATE AIRPORTS)

- 1. The Civil Aviation Authority Of The Philippines, Area Center V, Bicol International Airport through the CAAP Corporate Budget for CY 2022 intends to apply the sum of One Million One Hundred Ninety Seven Thousand Pesos (Php 1,197,000.00) being the ABC to payments under the contract for SUPPLY & DELIVERY OF DISASTER RESPONSE AND AIRPORT RESCUE EQUIPMENT AT CAAP AREA V (BIA, NAGA & MASBATE AIRPORTS)/CAAP BICOL INTERNATIONAL AIRPORT BAC CONTRACT NO. 2022-001. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Civil Aviation Authority Of The Philippines, Area Center V, Bicol International Airport now invites bids for the above Procurement Project. Delivery of the Goods is required by within forty five (45) calendar days. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. For this purpose, similar contract refers to the supply and delivery of various disaster response/fire rescue equipment for government or private agencies or other related contracts. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from the BAC Office, Civil Aviation Authority of the Philippines, G/F Admin Building, Bicol International Airport, Daraga, Albay, and inspect the Bidding Documents at the address given below from 8:00AM to 5:00PM, Monday to Friday.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

- A complete set of Bidding Documents may be acquired by interested Bidders on 24 February 2022 to 17 March 2022 from the given address below, and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of FIVE THOUSAND PESOS (Php 5,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person or through his authorized representative.
- 6. The Civil Aviation Authority Of The Philippines, Area Center V; Bicol International Airport will hold a Pre-Bid Conference¹ on 03 March 2022 at 2:00 p.m. onwards at the BAC Office, Civil Aviation Authority of the Philippines, G/F Admin Building, Bicol International Airport, Daraga, Albay which shall be open to prospective bidders.
- Bids must be duly received by the BAC Secretariat at the office address indicated below, on or before 2:00 p.m. of 17 March 2022.
- All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
- 9. Bid opening shall be on 17 March 2022 at 2:00 p.m. onwards at the BAC Office, Civil Aviation Authority of the Philippines, G/F Admin Building, Bicol International Airport, Daraga, Albay. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- The Civil Aviation Authority of the Philippines, Area Center V, Bicol International Airport shall resolve cases involving a tie, after post-qualification, among bidders determined and declared as the Lowest Calculated Responsive Bidder (LCRB), by drawing lots.

¹ May be deleted in case the ABC is less than One Million Pesos (PhP1,000,000) where the Procuring Entity may not hold a Pre-Bid Conference.

The Civil Aviation Authority Of The Philippines, Area Center V, Bicol International Airport reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
