**SUBJECT: RECOMMENDING THE AWARD OF BIDDING FOR THE PROJECT, PROCUREMENT OF TRUCKING SERVICES FOR TRANSFER OF X-RAY MACHINES FROM CAAP MAIN OFFICE TO VARIOUS AIRPORTS (NEGOTIATED PROCUREMENT)**

**WHEREAS**, in **BAC Resolution No. 2022-0823-078** dated 06 January 2023, the Bids and Awards Committee declared the 2<sup>nd</sup> bidding for the project, **Trucking Services of X-Ray Machines to Various Airports and Facilities**, a failure and a negotiated procurement to ensue. A copy of the BAC Resolution No. 2022-0823-078 is herein attached as *Annex "A"*;

**WHEREAS**, the Committee issued an Invitation for Negotiated Procurement of the said project dated 07 March 2023 to the prospective bidders. Copies of the Invitation Letter is hereto attached as *Annex "B"*;

**WHEREAS**, the Notice for Negotiated Procurement was posted in PhilGeps, CAAP Website, and in other conspicuous places on 09 March 2023. Copy of the Notice for Negotiated Procurement is hereto attached as *Annex "C"*

**WHEREAS**, the submission and opening of bids were held on 16 March 2023, at the CAAP Conference Room, Civil Aviation Authority of the Philippines, MIA Road, Pasay City, and via Google Meet Video Conference. Bidders submitted their bid proposal for the project, and the following result was noted. Copy of the Minutes of Meeting and Bidding Checklist are hereto attached as *Annexes "D" & "E"*, respectively;

**WHEREAS**, the Bids and Awards Committee Technical Working Group (BAC- TWG) issued its Bid Evaluation Report dated 17 April 2023 and presented to the BAC on the same day recommending the award of the project to Guard-All Electronics Security Systems, Inc for having complied with all the legal, technical and financial requirements in the bidding documents. WHEREAS, the Bids and Awards Committee Technical Working Group (BAC-TWG) recommends the Award of the Project under the guidelines indicated in the GPBB;

WHEREAS, Section 37.1.1 of 2016 IRR of RA 9184 provides that: *The BAC shall recommend to the HoPE the award of contract to the bidder with the LCRB, HRRB, SCRB, or SRRB after the post-qualification process has been completed.*;

NOW THEREFORE, premises considered, the CAAP-BAC RESOLVES, as it is hereby RESOLVED to recommend the APPROVAL and AWARD of the project, PROCUREMENT OF TRUCKING SERVICES FOR TRANSFER OF X-RAY MACHINES FROM CAAP MAIN OFFICE TO VARIOUS AIRPORTS (NEGOTIATED PROCUREMENT) in the total amount to One Million Nine Hundred Eighty-Eight Thousand Eight Hundred Forty Pesos (Php 1,988,840.00) to GUARD-ALL ELECTRONICS SECURITY SYSTEMS, INC.


