**SUBJECT: RECOMMENDING THE AWARD FOR THE PROJECT ENTITLED
PROVISION OF SECURITY SERVICES REQUIREMENTS FOR
CAAP AREA VII UNDER A THREE (3)-YEAR SERVICE
AGREEMENT**

WHEREAS, the project, **Provision of Security Services Requirements for CAAP Area VII Under a Three (3)-Year Service Agreement**, an ADMS project was forwarded to the Bids and Awards Committee of the Civil Aviation Authority of the Philippines (CAAP-BAC) for its procurement. The project has an approved budget amounting to **Seventy-Two Million Six Hundred Forty-Five Thousand Four Hundred Thirty Seven & 16/100 Pesos (Php72,645,437.16)**. A copy of the Certificate of Budget Allocation (CBA MOOE) No. 2022-08-0628 dated 31 August 2022 is herein attached and made an integral part of this Resolution as *Annex "A"*;

WHEREAS, Pre-Procurement Conference was conducted on 20 September 2022 via Google Meet Video Conference. Copy of the Minutes of Meeting hereto attached as *Annex "B"*;

WHEREAS, the Invitation to Bid (ITB) dated 04 October 2022 was posted in the Phil-GEPS, CAAP Official Website, CAAP Bulletin Board and in other conspicuous places in the CAAP premises, a copy of the Invitation to Bid is attached hereto as *Annex "C"*;

WHEREAS, Pre-bid Conference was conducted on 10 October 2022 via Google Meet Video Conference. Copy of the Minutes of Meeting hereto attached as *Annex "D"*;

WHEREAS, Bid Bulletin No. 1 dated 14 October 2022 was issued addressing the amendments and clarifications made in the bidding documents. Copy of the Bid Bulletin No.1 is hereto attached as *Annex "E"*;

WHEREAS, the Opening of Bids was held on 24 October 2022, at the CAAP Conference Room, Civil Aviation Authority of the Philippines, MIA Road, Pasay City. The following result was noted. Copy of the Minutes of Meeting and Abstract of Bids as Read hereto attached as *Annexes "F" and "G", respectively*;

WHEREAS, the Bids and Awards Committee Technical Working Group (BAC-TWG) issued its Bid Evaluation Report dated 03 November 2022 and presented to the BAC on 08 November 2022 where it is indicated that the tendered bid proposal of **GDS Security Agency Inc.** to undergo the Post- Qualification Process to determine whether the bidder concerned complies with and is responsive to all the requirements and conditions as specified in the bidding documents and is considered as the Single Calculated Bid. Copies of said Report and Minutes of Meeting are hereto attached as *Annexes "H" & "I"*, respectively;

WHEREAS, the Committee issued a letter to GDS Security Agency Inc. dated 08 November 2022 requiring the same to submit the necessary additional requirements for post-qualification. A copy of the said letter is hereto attached as *Annex "J"*;

WHEREAS, the BAC TWG issued its Post-Qualification Report dated 15 November 2022 and presented to the BAC on the same date, wherein the BAC TWG recommends the awarding of the contract to **GDS Security Agency Inc.** for being the Single Calculated and Responsive (SCRB). Copies of said Report and Minutes of Meeting are hereto attached as *Annexes "K" & "L"*, respectively;

WHEREAS, Section 37.1.1 of 2016 IRR of RA 9184 provides that: *The BAC shall recommend to the HoPE the award of contract to the bidder with the LCRB, HRRB, SCRБ, or SRRB after the post-qualification process has been completed.;*

NOW THEREFORE, premises considered, the **CAAP-BAC RESOLVES**, as it is hereby **RESOLVED** to recommend the **APPROVAL** and **AWARD** of the project, **PROVISION OF SECURITY SERVICES REQUIREMENTS FOR CAAP AREA VII UNDER A THREE (3)-YEAR SERVICE AGREEMENT to GDS SECURITY AGENCY INC.** in the total amount of **SIXTY-NINE MILLION THREE HUNDRED TWENTY - SIX THOUSAND THREE HUNDRED NINETY-EIGHT AND 08/100 PESOS (PHP69,326,398.08);**




