


If another form is used other than the latest RFQ, the quotation shall contain all th mandatory requirements/provisions including manifestation on the agreement with Terms and Conditions below.

- (3) All mandatory technical specifications (with asterisk) must be compiled with. Failure to comply with the mandatory requirements shall render the quotation ineligible/disqualified.

- 1. Bidders shall provide correct and accurate information required in this form.
- 2. Any interlineations, erasures, or overwriting shall be valid only if they are signed or initialed by you or any of your duly authorized representative/s.
- Price quotation/s must be valid for a period of thirty (30) calendar days from the deadline of submission.
- Price quotation/s, to be denominated in Philippine peso, shall include all taxes, duties, and/or levies payable.
- 5. Quotations exceeding the Approved Budget for the Contract shall be rejected.
- In case of two or more bidders are determined to have submitted the Lowest Calculated
 Quotation/Lowest Calculated and Responsive Quotation, CAAP Area Center III shall adopt
 and employ "draw lots" as the tie-breaking method to finally determine the single winning
 provider in accordance with GPPB Circular 06-2005.
- Award of contract shall be made to the lowest quotation which complies with the technical specifications, requirements and other terms and conditions stated herein.
- 8. The item/s shall be delivered according to the accepted offer of the bidder.
- Item/s delivered shall be inspected on the scheduled date and time of the CAAP Area
 Center III. The delivery of the item/s shall be acknowledged upon the delivery to confirm compliance with the technical specifications
- 10. Payment shall be made after delivery and upon the submission of the required supporting documents, i.e., Order Slip and/or Billing statement, by the supplier, contractor, or consultant. Our Government Servicing Bank, i.e., the Land Bank of the Philippines, shall consultant not earlier than twenty-four (24) hours, but not later than forty-eight (48) hours, upon receipt of our advice.
