Repair/Repainting Of VPA Fence Including Main Gate At Daet Airport

The Civil Aviation Authority of the Philippines (CAAP), Area Center V, Bicol International Airport intends to apply the estimated amount of Four Hundred Ninety Nine Thousand Three Hundred Pesos & 59/100 (Php 499,300.59) for the Repair/Repainting Of VPA Fence Including Main Gate At Daet Airport project.

The CAAP now requests you to submit price quotation on the item listed below, subject to the Specification and Terms and Conditions provided hereunder.

- 1. All entries must be printed.
- 2. Number of days to complete: Forty (40) calendar days.
- 3. Bid must be complete and award will be made on a lump sum basis.
- 4. Price validity shall be for a period of One Hundred Twenty (120) calendar days.
- 5. The following should be submitted together with the quotation:
 - 5.1 Valid PCAB License Small A;
 - 5.2 Current Mayor's/Business Permit;
 - 5.3 Phil-GEPS Registration Number;
 - 5.4 Name/credentials of proposed Construction Foreman, and Safety Officer; and
 - 5.5 List of completed similar projects within the last three (3) years, which must be related to any aerodrome works located at the airside, with attached supporting documents.
 - 5.6 List of Contractor's Equipment (Welding Machine and Bar Cutter)
 (The contractor's major equipment units, which are owned, leased, and/or under purchase agreements must be supported by proof of ownership, certification of availability of equipment from the equipment lessor/vendor for the duration of the project, as the case may be, which must meet the minimum requirements.
- 7. Other documentary requirements:
 - 7.1 Omnibus Sworn Statement (see attached format, maybe submitted together with the quotation or before issuance of Notice of Award.)
 - 7.2 Additional Requirements to be submitted before issuance of Notice To Proceed:
 - 7.2.1 Work Schedule;
 - 7.2.2 PERT/CPM;
 - 7.2.3 S-Curve;
 - 7.2.4 Manpower Schedule;
 - 7.2.5 Work Method;
 - 7.2.6 Construction Safety & Health Programs Approved by the DOLE*; and
 - 7.2.7 Performance Security.

*Copy of the CSHP received by the DOLE may be initially submitted together with the NOA, however, the DOLE approved CSHP must be immediately submitted upon approval.

Quotations not accompanied by current Mayor's/Business Permit, valid PCAB License; name/credentials of proposed Construction Foreman, and Safety Officer; list of completed similar projects; Phil-GEPS Registration Number; and list of contractor's equipment together with supporting documents shall be automatically disqualified.

Your prices must be quoted in Philippine Peso and must include the unit price and total price, inclusive of all taxes to be paid and other incidental cost to the delivery sites/project location if the contract is awarded. Quotations must be delivered to the Civil Aviation Authority of the Philippines, Area Center V not later than 2:00 p.m. on 07 July 2022 at its physical address at the BAC Office, Ground Floor Admin Bldg., Bicol International Airport, Daraga, Albay. Online submission is not allowed and late submission shall not be accepted.

All quotations together with the required documents should be placed in a sealed envelope marked Repair/Repainting Of VPA Fence Including Main Gate At Daet Airport.
