**SUBJECT: RECOMMENDING THE AWARD FOR THE PROJECT ENTITLED  
REPLACEMENT OF ILS 06 FOR NINYO AQUINO  
INTERNATIONAL AIRPORT**

**WHEREAS**, the project, **Replacement of ILS 06 for Ninoy Aquino International Airport**, an ANS project was forwarded to the Bids and Awards Committee-Alpha of the Civil Aviation Authority of the Philippines (CAAP-BAC-Alpha) for its procurement. The project has an approved budget amounting to **Sixty-Five Million Three Hundred Seventy-Seven Thousand Eight Hundred Four & 93/100 (Php65,377,804.93)**. A copy of the Certificate of Budget Allocation (CBA CO) No. 22-03-0188 dated 10 March 2022 is herein attached and made an integral part of this Resolution as *Annex "A"*;

**WHEREAS**, Pre-Procurement Conference was conducted on 19 May 2022 via Google Meet Video Conference. Copy of the Minutes of Meeting hereto attached as *Annex "B"*;

**WHEREAS**, the Invitation to Bid (ITB) dated 24 May 2022 was posted in the Phil-GEPS, CAAP Official Website, CAAP Bulletin Board and in other conspicuous places in the CAAP premises, a copy of the Invitation to Bid is attached hereto as *Annex "C"*;

**WHEREAS**, Pre-bid Conference was conducted on 31 May 2022 via Google Meet Video Conference. Copy of the Minutes of Meeting hereto attached as *Annex "D"*;

**WHEREAS**, Bid Bulletin No. 1 dated 06 June 2022 was issued and posted for amendments/ revision and clarification of bid documents. Copy of the Bid Bulletin No.1 is hereto attached as *Annex "E"*;

**WHEREAS**, Bid Bulletin No. 8 dated 12 August 2022 was issued informing the bidders that the Submission and Opening of the bids was rescheduled on 26 August 2022. Copy of the Bid Bulletin No. 8 is hereto attached as *Annex "L"*;

**WHEREAS**, the Bids and Awards Committee was reconstituted on 23 August 2022 (Authority Order No. 176-2022) for procurement activities requirements of CAAP Central Office. A copy of the Authority Order No. 176-2022 is hereto attached as *Annex "M"*;

**WHEREAS**, Bid Bulletin No. 9 dated 26 August 2022 was issued informing the bidders for the indefinite postponement of the said project. Copy of Bid Bulletin No. 9 is hereto attached as *Annex "N"*;

**WHEREAS**, Bid Bulletin No. 10 dated 31 August 2022 was issued informing the bidders that the Submission and Opening of the bids was rescheduled on 15 September 2022. Copy of the Bid Bulletin No. 10 is hereto attached as *Annex "O"*;

**WHEREAS**, the Opening of Bids was held on 15 September 2022, at the BAC Conference Room, Civil Aviation Authority of the Philippines, MIA Road, Pasay City and via Google Meet Video Conference. Bidder, Philcox Phils. Inc submitted their bids for the project and the following result was noted. Copy of the Minutes of Meeting and Bidding Checklist hereto attached as *Annexes "P" and "Q", respectively*;

**WHEREAS**, the Bids and Awards Committee Technical Working Group (BAC-TWG) issued its Bid Evaluation Report dated 27 September 2022 and was presented to the BAC on 27 September 2022 where it is indicated that the tendered bid proposal of PHILCOX Phils. Inc. to undergo the Post- Qualification Process to determine whether the bidder concerned complies with and is responsive to all the requirements and conditions as specified in the bidding documents and is considered as the Single Calculated Bid. **WHEREAS**, the Committee issued a letter to Philcox (Philippines) Inc dated 28 September 2022 requiring the same to submit the necessary additional requirements for post-qualification was sent to the bidder. A copy of the said letter is hereto attached as *Annex "T"*;

**WHEREAS**, the BAC TWG issued its Post-Qualification Report dated 03 October 2022 and presented to the BAC on 04 October 2022, wherein the BAC TWG recommends the awarding of the contract to Philcox (Philippines) Inc. for being the Single Calculated and Responsive (SCRB). Copies of said Report and Minutes of Meeting are hereto attached as *Annexes "U", and "V"*, respectively;


**WHEREAS**, Section 37.1.1 of 2016 IRR of RA 9184 provides that: *The BAC shall recommend to the HoPE the award of contract to the bidder with the LCRB, HRRB, SCRB, or SRRB after the post-qualification process has been completed.;*

**NOW THEREFORE**, premises considered, the **CAAP-BAC RESOLVES**, as it is hereby **RESOLVED** to recommend the **APPROVAL** and **AWARD** of the project, **REPLACEMENT OF ILS 06 FOR NINOY AQUINO INTERNATIONAL AIRPORT** to **PHILCOX (Philippines) Inc** in the total amount of **SIXTY-THREE MILLION THREE HUNDRED SEVENTY THOUSAND PESOS (Php63, 370,000.00);**


