This Supplemental/Bid Bulletin clarifies the queries and other matters relative to the public bidding for the **Supply and Delivery of Body Cameras for Various Airports – BID NO. 22-018-10**.

The modifications, amendments or clarifications are as follows:

I. Amendments in the Bidding Documents:

The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).</i>	<i>The CAAP now invites bids for the above Procurement Project. Delivery of the Goods is required <b>within thirty (30) calendar days</b>. Bidders should have completed, <b>within Three (3) years</b> from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).</i>
