This Supplemental/Bid Bulletin clarifies the queries and other matters relative to the public bidding for the **Provision of Security Services Requirements for CAAP Area VIII under a Three (3) Year Service Agreement (Re-Bid) – BID NO. 22-013-10.**

The modifications, amendments or clarifications are as follows:

I. **Queries/Questions raised during the Pre-bid Conference held on December 20, 2022 by Prospective Bidders:**

1. <i>I just want to clarify on Tab "N" which is the site security survey and I believe that it is prior to the submission of bids we will conduct or we will go to the sites for the security survey right?</i>	<i>Upon presentation a proof of purchase or receipt of the bidding documents in person or thru email, CAAP will issue Authority to Conduct Site Inspection duly signed by ADG II/Chief, CSIS to be able to conduct security site survey to the airports/facilities included in this project.</i>
2. <i>I believe your cost your costing also reflects SSS 2021, however we already have a notice from SSS that we will be increasing by January 1, 2023, we will still be used the 2021 SSS contribution right?</i>	<i>Yes, the 2021 SSS contribution will be the basis for the computation for this project. However, a Supplemental Contract will be issued during the implementation of the new SSS contribution.</i>

3. <i>We have a question on page 25, this is regarding price of goods computed based on Region VIII Eastern Visayas DOLE Wage Order No. RB VIII – 21 Class B effective date June 27, 2022. Actually the 2nd Tranche of this is on January 2, 2023, so are we going to use the RBVIII -22 or RBVIII – 21?</i>	<i>The basis of the computation for the Approved Budget of the Contract (ABC) is based on the DOLE Wage Order No. RBVIII-21 Class B. However, a Supplemental Contract will be issued during the implementation of the new Wage Order Adjustment.</i>

- II. This shall be an integral part of Bidding Documents and the same shall be enclosed in the technical bid envelope/components and shall be marked accordingly.
- III. Bids not complying with the above instruction shall be disqualified.
