- 1. The Civil Aviation Authority of the Philippines (CAAP) through its Bids and Awards Committee intends to apply the sum of FOUR MILLLION SEVEN HUNDRED TWENTY-EIGHT THOUSAND THREE HUNDRED FIFTY-ONE & 35/100 PESOS (Php4,728,351.35), inclusive of all applicable government taxes, fees, and charges, being the Approved Budget for the Contract (ABC) to payments under the contract for the project SUPPLY & DELIVERY OF SPAREPARTS FOR INDRA DVOR/DME OF VARIOUS AIRPORTS
- The BAC requests Ryan Earl So, Authorized Signatory of Indra Philippines, Inc., to submit a PRICE PROPOSAL in Philippine Peso (Inclusive of VAT). Proposal received more than the ABC shall be automatically rejected at proposal opening.
- 3. The Submitted Eligibility, Technical and Financial documents shall be properly marked with index tabs (ear tab) and must be sequentially paginated in accurate order in the form i.e. "page 3 of 100". Page number of last page of the document (per envelope basis).

Pagination should be sequential based on the entire span of the whole documents inside the envelope.

4. The submission shall include the following documents:

- Prospective bidder's computation of Net Financial Contracting Capacity (NFCC)

- Indra Philippines, Inc.,, shall submit its quotation/proposal manually to the Bids and Awards Committee on or before 10:00am on 14th of February 2023 at the BAC Office, PMO Building, Civil Aviation Authority of the Philippines, MIA Road, Pasay City.

Late submission shall not be accepted.

Quotation opening shall be held physically at the CAAP Conference Room,4/F Admin Building, Civil Aviation Authority of the Philippines, MIA Road, Pasay City and virtually via Google Meet Video Conferencing. The quotation will be opened in the presence of the bidder's representative/s who opts to attend the activity. The bidder is requested to advise the committee, through the Secretariat of the name of its representative together with an attached written authorization manually or via electronic mail.

The CAAP reserves the right to accept of reject the offer, to annul this request for quotation or the procurement process, waive any informalities or minor defects, accept the most advantageous offer to the CAAP, or not award the contract without thereby incurring any liability to the offer.

This Alternative Method of Procurement through Direct Contracting for the project stated above shall be governed by Section 50 (c) of the Revised Implementing Rules and Regulations of Republic Act 9184.
