SUBJECT: SUPPLY AND DELIVERY OF SPARE PARTS FOR ROHDE & SCHWARZ VCS AT PANGLAO AIRPORT

WHEREAS, the Supply and Delivery of Spare Parts for Rohde & Schwarz VCS at Panglao Airport, an ANS Project was forwarded to the Bids and Awards Committee of the Civil Aviation Authority of the Philippines (CAAP-BAC) for its procurement. The project has an approved budget in the amount of Two Million Four Hundred Forty Thousand Two Hundred Sixty-Seven & 15/100 Pesos (Php2,440,267.15). A copy of CBA (MOOE) # 22-05-381 is attached and made an integral part of this Resolution as *Annex* "A";

WHEREAS, a Notice of Direct Contracting and Request for Quotation dated 16 December 2021 was issued and posted at the PhilGeps Website. A copy of the letter is attached as Annex "B";

WHEREAS, Bid Bulletin 01 dated 27 December 2021 was issued, re-scheduling the Submission and Opening of Bids on 06 January 2022. A copy of the Bid Bulletin is attached as Annex "C";

WHEREAS, Bid Bulletin 02 dated 06 January 2022 was issued, re-scheduling the Submission and Opening of Bids on 14 January 2022. A copy of the Bid Bulletin is attached as Annex "D";

WHEREAS, Bid Bulletin 03 dated 13 January 2022 was issued, re-scheduling the Submission and Opening of Bids on 24 January 2022. A copy of the Bid Bulletin is attached as Annex "E";

WHEREAS, Bid Bulletin 04 dated 21 January 2022 was issued, re-scheduling the Submission and Opening of Bids on 31 January 2022. A copy of the Bid Bulletin is attached as Annex "F";

WHEREAS, the Opening of Bids was held on 31 January 2022 at the CAAP Conference Room, Civil Aviation Authority of the Philippines, MIA Road, Pasay City. The following results were noted. A copy of the Minutes of Meeting and Abstract of Bids as Read are attached as *Annexes* "G" and "H", respectively;

WHEREAS, the Bids and Awards Committee Alpha-Technical Working Group (BAC Alpha-TWG) issued its Bid Evaluation Report dated 02 February 2022 for the Completeness of Bids and Arithmetical Corrections and presented the same on 11 March 2022. The TWG recommended that the bid proposal of Rohde & Schwarz (Philippines) Inc. to undergo Post-Qualification process for being evaluated and considered as the Single Calculated Bid (SCB). Copies of said Report and Minutes of Meeting are attached as Annexes "I" and "J" respectively;

WHEREAS, the Committee issued a letter to Rohde & Schwarz (Philippines) Inc. dated 17 May 2022 requiring the same to submit the necessary additional documents for post-qualification. A copy of the letter is attached as *Annex "K"*;

WHEREAS, the Bids and Awards Committee Alpha-Technical Working Group (BAC Alpha-TWG) issued its Post Qualification Report dated 31 May 2022 and presented to the BAC Alpha on 14 June 2022. The TWG, upon its evaluation, finds that the bid proposal of Rohde & Schwarz (Philippines) Inc. was responsive as to the legal, technical and financial requirements and recommends the award of the project to the said bidder. Copy of the said Report and Minutes of Meeting are attached as *Annexes "L" & "M"*, respectively;

WHEREAS, Section 34.4. of the 2016 Revised Implementing Rules and Regulations (IRR) of the Government Procurement Reform Act (R.A. 9184) provides that "If the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid passes all the criteria for post-qualification, it shall declare the said bid as the LCRB or HRRB, and recommend to the HoPE the award for contract to the said bidder at its submitted bid price or its calculated bid price, whichever is lower or...";

NOW THEREFORE, the CAAP-BAC ALPHA RESOLVES, as it is hereby RESOLVED to recommend the APPROVAL and AWARD of the project, Supply & Delivery of Spare Parts for Rohde & Schwarz VCS at Panglao Airport in the total amount of TWO MILLION FOUR HUNDRED THIRTY-FIVE THOUSAND THREE HUNDRED TWENTY-SEVEN PESOS AND 75/100 (Php2,435,327.75) to Rohde & Schwarz (Philippines) Inc;
