POWER SUPPLIES (UPS) AT MANILA CNS/ ATM FACILITY

WHEREAS, the project, Supply, Delivery & Installation of Two (2) Sets of 250KVA, 3 Phase, 380 VAC, WY,60HZ Uninterruptible Power Supplies (UPS) At Manila CNS/ ATM Facility, an ANS project was forwarded to the Bids and Awards Committee of the Civil Aviation Authority of the Philippines (CAAP-BAC) for its procurement. The project has an approved budget amounting to Fourteen Million Two Hundred Sixty- Seven Thousand Five Hundred Pesos (Php14,267,500.00). WHEREAS, the Submission and Opening of Bids was held on 05 January 2023 at the BAC Conference Room, Civil Aviation Authority of the Philippines, MIA Road, Pasay City and via Google Meet Video Conference.
