AEROMEDICAL ADVISORY No. 02 - 2022

This Advisory is applicable to all holders of Aviation Medical Certificates issued by the Authority under the Philippine Civil Aviation Regulation (PCAR) Part 2.10. Initial, Renewal, and Re-issuance of aviation medical certificate for all Classes shall be covered by this advisory.

As movement and travel restrictions continued to ease up and in an effort to comply with the medical provisions of PCAR Part 2.10 on airmen licensing, all physical examinations and assessment of airmen for various Classes of Aviation Medical Certification shall be conducted at the Office of the Flight Surgeon and Aviation Medicine (OFSAM) by current CAAP Aviation Medical Examiners (AMEs) and Designated Aviation Medical Examiners (DAMEs).

Schedule of conduct of physical examination at OFSAM shall remain by appointment.

This Advisory also reiterates PCAR Part 2.10.2.4.5(b) to wit:

"A scheduled commercial air operator Medical Examiner shall not perform medical examination of airmen of the scheduled commercial operator for the purpose of securing original or renewal of airmen licenses or rating(s). He shall be mainly concerned in keeping the flight crew members of the scheduled commercial air operator physically and mentally fit to perform flight duties at all time."

Furthermore, all are directed to strictly comply on the Routine Test Requirement included in the application and those airmen with Special Medical Requirement.

Blood Chemistry	Required upon reaching the applicant's 40 th birthday and annually thereafter but may vary to those cases that require monitoring.
Audiogram	Required every 5 years from initial application but may vary to those cases that require monitoring.
Chest Radiograph	Required annually
ECG	Required annually until the applicant's 39 th birthday.
Treadmill Stress Test	Required upon reaching the applicant's 40 th birthday and annually thereafter but may vary to those cases that require monitoring.

Audiogram	Required every 5 years from initial application but may vary to those cases that require monitoring.
Chest Radiograph	Required annually.
ECG	Required every 2 years after reaching the applicant's 30 th birthday and annually after reaching the 40 th birthday.
Treadmill Stress Test	Required every 2 years after reaching the applicant's 50 th birthday and yearly after reaching 60 th birthday

ECG	Required annually until the applicant's 39 th birthday.			
Treadmill Stress Test	Required upon reaching the applicant's 40 th birthday and annually thereafter but may vary to those cases that require monitoring.
