## RESOLUTION DECLARING LOWEST CALCULATED RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL FOR SUPPLY AND DELIVERY OF OFFICE SUPPLIES FOR FEBRUARY TO APRIL 2021 AT ILOILO INTERNATIONAL AIRPORT

WHEREAS, BAC Resolution No. BSVP 2021-004-01 for the project Supply and Delivery of Office Supplies for February to April 2021 at Iloilo International Airport with Approved Budget for the Contract (ABC) in the amount of Two Hundred Twenty One Thousand Nine Hundred Fifty Four Pesos (\$\mathbb{P}221,954.00)\$ hereby form the integral part of this resolution. A copy is herewith attached as Annex A;

WHEREAS, (3) Request for Quotations (RFQ) were distributed to different suppliers;

WHEREAS, Acknowledgement Receipts are herewith attached as proof that copies of Request for Quotation (RFQ) were distributed;

WHEREAS, four (4) interested suppliers submitted their sealed quotations;

WHEREAS, during the opening of quotations, NEWTON MERCHANDISING, INC. violated the Terms and Conditions No. 6 "Quotation exceeding the Approved Budget for the Contract shall be rejected." as stated in the Request for Quotation;

WHEREAS, the price quotation of the bidder were found to be substantially compliant:

**NOW THEREFORE,** We, the Members of the Bids and Awards Committee hereby RESOLVE as it is hereby RESOLVED:

a) To disqualify, **NEWTON MERCHANDISING**, **INC**. for quoting above the Approved Budget for the Contract;

- b) To declare, ILOILO IZEEM COMMERCIAL as the Supplier with the Lowest Calculated Responsive Quotation SUPPLY AND DELIVERY OF OFFICE **SUPPLIES FOR FEBRUARY** TO APRIL 2021 AT HOILO INTERNATIONAL AIRPORT in the bid amount Two Hundred Nineteen Thousand One Hundred Ninety Seven Pesos (# 219,197.00);
- c) To recommend for approval by the Head of the Procuring Entity of the Civil Aviation Authority of the Philippines the foregoing findings.
