 In relation to Bid Data Sheet ITB Clause 11.1; Bid Form (BF - Form 14) and Financial Proposal Sheet (BF - Form 15) shall be used for the Bidder's sum of financial proposal. The Bidder shall also submit its Bill of Quantities (BOQ) using the forms (BF - Form 16) under Section VII Bidding Forms. 	The Bidder shall use the 393.5 days/year as indicated in the BOQ. Any adjustment based on the provisions of DOLE shall be effected during the implementation of the project.
The Bidder cannot change or modify the items, formulate amounts indicated in the BOQ and should supply only the amounts corresponding to Agency fee, Value Added Tax and Minimum Contract Rate. Bid not complying with the above instruction shall be disqualified.	
"Please be informed that the DOLE now uses 393.8 days/years instead of 393.5 days/year which is the one used in the BOQ in relation to this we would like to ask for your guidance as to which figure we should use"	

 Inquiry in relation to Supplemental Bid Bulletin no. 1 specifically number 5 which states that

Prospective Bidder should have the minimum number of motor-powered vehicles:

- (a) 1 unit 4 wheeled vehicle
- (b) 6 units motorcycle (at least 150 cc)

"We would like to clarify if an "Affidavit of Undertaking or an Affidavit of Commitment" from the Bidder that the said vehicles will be ready before the contract award will suffice?" Refer to Section III Bid Data Sheet ITB Clause 10.1 Technical Documents letter h item no. 12

"Certificate of Availability of the required Transportation/Vehicle to be supplied by the Private Security Agency (BF – Form 11)"
