WHEREAS, (3) Request for Quotations (RFQ) were distributed to different suppliers;

WHEREAS, Acknowledgement Receipts are herewith attached as proof that copies of Request for Quotation (RFQ) were distributed;

WHEREAS, two (2) interested suppliers submitted their sealed quotations;

WHEREAS, during the opening of quotations, UNI-ART SUPPLY, INC. violated the Terms and Conditions No. 3 "Bidders must quote for all the items." as stated in the Request for Quotation. UNI-ART SUPPLY, INC. failed to indicate what brand or if generic for the items provided.

WHEREAS, the price quotation of the bidder was found to be substantially compliant:

NOW THEREFORE, We, the Members of the Bids and Awards Committee hereby RESOLVE as it is hereby RESOLVED:

- a) To disqualify, UNI-ART SUPPLY, INC., for not indicating the brand or generic (Mandatory);
- b) To declare, ILOILO IZEEM COMMERCIAL as the Supplier with the Single Calculated Responsive Quotation SUPPLY AND DELIVERY OF JANITORIAL SUPPLIES FOR FEBRUARY TO APRIL 2021 AT ILOILO
