**RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION  
AND RECOMMENDING APPROVAL FOR REPAIR AND MAINTENANCE OF  
DUMP TRUCK AT ILOILO INTERNATIONAL AIRPORT**

**WHEREAS**, BAC Resolution No. BSVP 2021-016-08 for the project **Repair and Maintenance of Dump Truck of Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **One Hundred Eighteen thousand One Hundred Pesos (₱ 118,100.00)** hereby form the integral part of this resolution.
