RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL FOR REPAIR AND MAINTENANCE OF BACKHOE LOADER AT ILOILO INTERNATIONAL AIRPORT

WHEREAS, BAC Resolution No. BSVP 2021-017-03 for the project Repair and Maintenance of Backhoe Loader at Iloilo International Airport with Approved Budget for the Contract (ABC) in the amount of One Hundred Sixty Seven Thousand Two Hundred Pesos (**P 167,200.00**) hereby form the integral part of this resolution.
