RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL FOR SUPLY AND DELIVERY OF EMERGENCY LIGHT (WALL MOUNTED), MEASURING WHEEL AND DEHUMIDIFIER OF ILOILO INTERNATIONAL AIRPORT

WHEREAS, BAC Resolution No. BSVP 2021-035-02 for the project Supply and Delivery of Emergency Light (Wall Mounted), Measuring Wheel and De-Humidifier of Iloilo International Airport with Approved Budget for the Contract (ABC) in the amount of Sixty Five Thousand Eight Hundred Ninety Five Pesos (\$\mathbb{P}\$ 65,895.00) hereby form the integral part of this resolution.
