RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL FOR SUPPPLY AND DELIVERY OF SUPPLIES OF GROUND MAINTENANCE OF ILOILO INTERNATIONAL AIRPORT
