**RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION
 AND RECOMMENDING APPROVAL FOR REPAIR AND MAINTENANCE OF
 AERIAL WORKING PLATFORM AT ILOILO INTERNATIONAL AIRPORT**

WHEREAS, BAC Resolution No. BSVP 2023-034-01 for the project **Repair and Maintenance of Aerial Working Platform at Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **Two Hundred Seventy Six Thousand Five Hundred Pesos (P 276,500.00)** hereby form the integral part of this resolution. A copy is herewith attached as Annex A;

WHEREAS, (3) Request for Quotations (RFQ) were distributed to different suppliers;

WHEREAS, Acknowledgement Receipts are herewith attached as proof that copies of Request for Quotation (RFQ) were distributed;

WHEREAS, one (1) interested supplier submitted their sealed quotations;

WHEREAS, during the Bid Opening last September 12, 2023, **WILAN MERCHANDISING PHILS., INC.** was declared Single Calculated Bid with the Bid amount of **Two Hundred Seventy Six Thousand Five Hundred Pesos (P 276,500.00)**;

WHEREAS, the price quotation of the bidder was found to be substantially compliant:
