1. Bidders must provide correct and accurate information required in this form.

2. Only authorized representative shall be allowed to sign the Request For Quotation in behalf of the owner/ corporation.

3. Bidders must quote for all the items.

4. Price quotation/s must be valid for a period of Thirty (30) calendar days from the date of submission.

5. Price quotation/s, to be denominated in Philippine peso shall include all taxes, duties and/or levies payable.

6. Bidders must indicate Expiry Date of Drugs and Medicines must not be earlier than 2025. Should the contractor provide an earlier date, the end-user may request for replacement.

7. Bidder must have the following:

• Certification issued by the Department of Health (DOH) that has registered and complied with the requirement of uploading its data in the Electronic Drug Price Monitoring System (EDPMS);

• License to Operate issued by the Food and Drug Administration (FDA) in accordance to RA 9711 "Food and Drug Administration (FDA) Act of 2009" and related issuances.

8. Quotations exceeding the Approved Budget for the Contract shall be rejected.

9. Award of contract shall be made to the lowest quotation (for goods and infrastructure) or, the highest rated offer (for consulting services) which complies with the minimum technical specifications and other terms and conditions stated herein.

10. Any interlineations, erasures or overwriting shall be valid only if ther are signed or initiated by you or any of your duly authorized representative's

11. The item/s and project shall be completed within Thirty (30) calendar days from receipt of purchase order.

12. The GPPB-TSO shall have the right to inspect and/or to test the goods to confirm their conformity to the technical specifications.

13. Liquidated damages equivalent to one tenth of one percent (0.001%) of the value of the goods not delivered withn the prescribed delivery

period shall be imposed per day of delay. The GPPB-TSO shall rescind the contract once the cumulative amount of liquidated damages

reaches ten percent (10%) of the amount of the contract, without prejudice to other courses of action and remedies open to it.
