RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL FOR SUPPLY AND DELIVERY OF PLASTIC TRASH BINS WITH FRAMES (3 SLOTS) AT ILOILO INTERNATIONAL AIRPORT

WHEREAS, BAC Resolution No. BSVP 2021-028-02 for the project Supply and Delivery of Plastic Trash Bins with Frames (3 slots) at Iloilo International Airport with Approved Budget for the Contract (ABC) in the amount of One Hundred Twenty Five Thousand Seven Hundred Sixty Pesos (**P 125,760.00*) hereby form the integral part of this resolution.
