## INVITATION TO BID FOR

## PROVISION OF SECURITY SERVICES REQUIREMENTS FOR CAAP AREA IV UNDER A THREE (3)-YEAR SERVICE AGREEMENT

- 1. The CIVIL AVIATION AUTHORITY OF THE PHILIPPINES (CAAP), through the Corporate Operating Budget (COB) for FY 2023 intends to apply the sum of Twenty-nine Million Five Hundred Seventy-eight Thousand Six Hundred Seventy-nine pesos and 16/100 (Php 29,578,679.16) for the First One Year only, being the ABC to payments under the contract for PROVISION OF SECURITY SERVICES REQUIREMENTS FOR CAAP AREA IV UNDER A THREE (3)-YEAR SERVICE AGREEMENT-BID NO. 23-040-10 BRAVO. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The CAAP now invites bids for the above Procurement Project (see details in the attached Terms of Reference). Delivery of the Services is required for a period of three (3) years. Bidders should have completed, within Three (3) years (CY 2020 to present) from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

- All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
- 10. Bid opening shall be on 06 November 2023, 9:30 AM at the given address below and/or via Google Meet. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 11. The CAAP reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
