INVITATION TO BID FOR

PROVISION OF SECURITY SERVICES REQUIREMENTS FOR CAAP AREA IX UNDER A THREE (3)-YEAR SERVICE AGREEMENT

- 1. The CIVIL AVIATION AUTHORITY OF THE PHILIPPINES (CAAP), through the Corporate Operating Budget (COB) for FY 2023 intends to apply the sum of Forty-one Million Eight Hundred Eighty-two Thousand Three Hundred Two Pesos and 20/100 (Php 41,882,302.20) for the First One Year only, being the ABC to payments under the contract for PROVISION OF SECURITY SERVICES REQUIREMENTS FOR CAAP AREA IX UNDER A THREE (3)-YEAR SERVICE AGREEMENT- BID NO.23-043-10 BRAVO. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The CAAP now invites bids for the above Procurement Project (see details in the attached Terms of Reference). Delivery of the Services is required for a period of three (3) years. Bidders should have completed, within Three (3) years (CY 2020 to present) from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

- Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- 4. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of

- the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- Prospective Bidders may obtain further information from the CAAP Bids and Awards Committee for Security Services and inspect the Bidding Documents at the address given below during Regular Office Hours from 8:00 A.M. to 5:00 P.M. (Monday to Friday).
- 6. A complete set of Bidding Documents may be acquired by interested Bidders until the deadline of submission of bids from Civil Aviation Authority of the Philippines, BAC Office, MIA Road, Pasay City and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php 28,000.00. The Procuring Entity shall allow the bidder to present its proof of payment for the fees by presenting the official receipt in person or through email.
- 7. The CAAP will hold a Pre-Bid Conference¹ on 20 October 2023, 9:30 AM through video conferencing or webcasting *via* Google Meet, which shall be open to prospective bidders.
- Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before 06 November 2023, 9:30 AM. Late bids shall not be accepted.
- All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
- 10. Bid opening shall be on 06 November 2023, 9:30 AM at the given address below and/or via Google Meet. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 11. The CAAP reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
